Dynastic rulers eventually allowed only the ruling classes throughout China to use Ming Cheng Bio. Manufacture of the formulation by anyone, other than the Imperial Pharmacy, was punishable. # Ming Cheng Bio/Life Enhancer

Ming Cheng Bio is manufactured from a well processed, pure, natural plants through extraction and concentration. It has been confirmed by experiment that the anthraquinone compound in Ming Cheng Bio can promote enteroeristalsis, prevent the re-absorption of cholesterol in the intestine and improve the metabolism of cholesterol. Its biphenyl-alkaline compound has also been shown to reduce cholesterol in the blood of a rat. Its lecithin can prevent the deposit of cholesterol in the liver and thus avoid retention of **lipoid** in serum and permeation into arterial intima therefore reducing arteriosclerosis.
